# VISIT OF INDIAN DELEGATION TO SPECIAL ECONOMIC ZONE

A visit to Special Economic Zone for Indian Delegation was organized on 28th November 2013 at 10 a.m. by the Rwanda Development Board to appraise/attract Indian investors for establishing business/industries in Rwanda. There are few players from China, Uganda etc. who have already established their units. There are ample of opportunities for infrastructure industry.

A small foam mattress unit was also seen present. The Rwandan Govt. is assuring various incentives for the Investors. The Indian companies may try possibly Rubberized Coir mattress industry which might facilitate to cater to African markets.

## HIGH LEVEL DELEGATION MEETING

A high level delegation meeting was held at 1 p.m. on 28th November at the Board room of the Rwanda Development Board with the Indian delegation. The senior officers from the Ministry of SME, Industry experts, and banking/infrastructure sector officials were present and briefed all that the Rwandan Govt. offers for the overseas investors with zero percent tolerance on corruption.

It was told that anybody can buy the land/property at Rwanda at the price that the locals can buy and the Govt. will organize registration/documentation within 3 days. This should be a great opening for Indian players and venture capitalists to take advantage of the opportunity.

#### TVET EXPO SYMPOSIUM

The TVET Symposium was held at Gikondo Expo grounds on 29<sup>th</sup> November 2013. The symposium began with welcome remarks, then keynote address by Hon'ble Minister of State for TVET. The symposium deliberated on various topics such as;

It was followed by an open session addressed by the following Ministers;

Burundian TETVT, Uganda BTVET, Congo Brazaville TVET, Ethiopia and ultimately Indian Minister of State with independent charge for Micro, Small and Medium Enterprises (MSME), Shri. K.H.Muniyappa. While he appreciated the steps taken by the Rwandan Govt, he also reiterated the need for such developments in all the African countries and India is very happy to cooperate in the developmental front. He has also highlighted the trend and the latest technologies in MSME Sector in India.

### TRADE OPPRORTUNITIES

The Rwanda is one of the upcoming African countries having strong administration with determination to bring the country to the main stream. The pace of the development is quite appreciable and by 2020 the face of the country is likely to take a 'U' turn. Since it is in the stage of inception in definite development, trade and industry may flourish by 2020. The opportunity therefore for the overseas investors is unlimited. The business enquiry generated may be incidental due to the absence of the coconut or coir

but it doesn't restrict use of the coir particularly in infrastructure development, more specifically roads/ embankment protection projects for Geo-Textiles. So far a lot of work has been done for the beautification /embankment protection in infrastructure work and a lot more to be done. Presently the German enterprise has done the work on a contract using brick and grass as shown below, while no construction material including brick is produced there.



Presently used product & green technique for the slope stabilization cum beautification in Kigali – Rwanda & the Parliament Building is atop; the cost effective coir geo-textile can effectively substitute the present system

In other words the Coir Geo-textiles for bio-engineering applications

would bring down the cost enormously while giving a good opening for Indian

Coir, if systematically tapped. This requires intense intervention and

interaction at appropriate level mainly with the private participation.

There were few general enquiries about the products on minimal scale. The

extract of the visitor's book is furnished.

CONCLUSION

The country doesn't have coconut cultivation and the nearest place

where coconut is grown is Tanzania, the neighbor country. There are ample of

opportunities for the venture capitalists to invest in overseas country to

establish manufacturing units and service providers particularly for

Rubberized Coir Mattress manufacturers and suppliers and service providers

of Coir Geo-Textiles Road/Embankment protection/Stabilization/

Beautification with the private participation and Govt. facilitation.

Therefore, it is recommended that this information may be circulated in

the industry for the best advantage of the trade.
