The important events/discussions/decisions pertaining to Coir Board for the month of **August 2013** are furnished below.

I. S&T ACTIVITIES

- As a part of popularization of machineries developed by the Board, 3
 demonstrations of Mobile Fiber Extraction Machine were organized at field
 level.
- Shri. S.N. Tripathi, IAS, Joint Secretary to Govt. of India, visited Central Coir Research Institute on 28.08.2013 and reviewed the functioning of various departments in the institute and also National Coir Training &Design Centre and Hindustan Coir. On this occasion, the machineries and technologies developed under R&D programmes were demonstrated. He opined that the industry should be associated with the research works from the very beginning of the projects, so that smooth transmission of

- technologies developed by the institute could be effected. He visited the Head Office of the Board at Kochi also and released Board's Official Language Home Magazine.
- Coir Board participated in the one day seminar organized by BMTPC, Ministry of Housing and Urban Poverty Alleviation, Govt. of India at New Delhi on 23.08.2013. Shri R.Vasudev, Senior Scientific Officer, CICT, Bangalore represented the Board in the seminar and made a presentation on Coir Composite, the innovative coir product developed by the Board.

II. EXPORT MARKETING.

Participation in the Textil House Fair, Sao Paulo, Brazil

Coir Board facilitated participation of Indian coir sector in the Textil House Fair, Sao Paulo, Brazil held during 18-21 August, 2013. It was a Trade Show for Textiles and Home Furnishings. The fair attracted the visitors not only from the host country but also from the neighbouring countries like Chile, Argentina and Greece. Brazil being a big country and emerging as a Financially Sound Nation with good GDP, there is more potential for coir products in the Agri/Soil conservation areas. Textil House Fair was a truly global business platform with the scope and reach to attract Latin American markets. Participation in the fair was very effective and all the participants could bag good number of trade leads.

III. SCHEME FOR "REJUVENATION, MODERNIZATION AND TECHNOLOGY UPGRADATION OF COIR INDUSTRY" (REMOT)]

1. Meeting with Banks

Coir Board Officials attended a meeting convened by the Regional Director, Reserve Bank of India at Thiruvananthapuram on 19.08.2013. The banks have been directed to process the pending REMOT applications with them in order to utilize the funds available with the Coir Board under the Scheme.
