4. The bidder should submit the tender in a sealed cover giving full details with supporting documents as required. The sealed envelope should be superscripted as "QUOTATION FOR HOARDINGS".
5. The rate/s finalized through this process, will be operative for a period of 06 (six) months.
6. Request from the bidder for additions, alterations, modifications and corrections with regard to terms and conditions or rates after opening of the Quotations shall not be entertained / considered.
7. The selected bidder shall also be responsible for maintenance of the hoardings for one year from the date of erection of the hoarding on payment.
8. The successful bidder will have to obtain prior permission from the competent authority.
9. Dispute, if any, arising out of the contract shall be filed by either party in a court of law to which the jurisdiction of the Hon'ble High Court of Kerala extends.
10. The matter for display and art work in the hoardings will be submitted by this office.
11. Technical Bid and Financial Bid should be submitted in separate sealed covers.
