Construction of Modular Kitchen

1. Competitive sealed quotations in two bid system are invited for construction of modular kitchen at the residential building of Coir Board at Coir House, Panampilly Cross Road, Opp: SBT Zonal Office, Panampilly Nagar, Kochi. The site can be inspected by the interested parties during 10am to 5pm on all working days (Monday to Friday).

2. The pattern / model of the modular kitchen and the specification of the materials to be used for construction are as given in the attached sheet (next page).

3. Technical Bid :

A) Financial position: Average annual financial turn over (during last three years) ending 31st March of the previous financial years may be stated.

B) Experience: Contractor should adequate experience in similar works. Attach supporting documents for experience.

C) Drawings, materials to be used for the construction should be included along with technical bid.

4. Financial Bid :

A) Rate quoted should be all inclusive of construction, installation, and Commissioning of the equipments and all tax liabilities.

5. The technical bid and the financial bid should be sealed by the bidder in separate covers and superscribed as " Technical/Financial bid for construction of modular kitchen for residential quarters". Both these sealed covers are to be put in a bigger cover which should also be sealed and superscribed.

6. The tender documents and other details can be had from the Office of the Coir Board, MG.Road, Kochi-682016 on all working days till the last date. The cost of tender form will be Rs.100/-, which may be remitted by NEFT (a/c no:57009832813 .IFSC Code : SBTR0000261, State Bank of Travancore, Perumanoor Branch) or by a crossed DD drawn from any nationalised bank in favour of Secretary, Coir Board payable at Ernakulam.

7. One tenderer can submit only one tender and alternative tenders will not be accepted. The dates of issue and opening of the tenders are detailed below:

ii) Opening of the tenders : 12/01/2017 at 15.30 hrs

8. Rate quoted should be all inclusive of construction, installation and Commissioning of the equipments and all tax liabilities. There will be negotiation with the lowest quoted tenderer, if necessary, as per the CVC guidelines which will be held on a later date after opening of the tenders.

9. Earnest Money Deposit of Rs. 3,000/- is to be remitted by NEFT (a/c no:57009832813 .IFSC Code : SBTR0000261, State Bank of Travancore, Perumanoor Branch) or by a crossed DD drawn from any nationalised bank in favour of Secretary, Coir Board payable at Ernakulam.

10. No advance payment will be made for the supply / construction of the items tendered. The payment will be one time payment, after completion and handing over of the construction. The works have to be completed in the pattern provided within 14 days. In the event of any deviation from the approved pattern provided for construction or time limit, no payment will be released.

11. Tenders received after the due date and time will not be accepted under any circumstances.

12. Tenders without the EMD will not be considered.

13. SSI units having valid registration with NSIC are exempted from payment of EMD. Attested copy of the Registration Certificate with NSIC should be attached along with the tender document in the technical bid cover.

14. copies of ST,VAT and PAN may be enclosed.

15. The Secretary, Coir Board reserves the right to accept or reject any or all the tenders in full or part without assigning any reasons whatsoever.
