QUOTATION NOTICE

Competitive quotations are invited from reputed manufactures/suppliers of Coir Yarn for the supply of the following varieties of Coir Yarn as and when required to Hindustan Coir at Kalavoor, Alappuzha- 688 522 in Kerala State.

1. Anjengo rehanked yarn 200-220 M/Kg.
2. Vycome rehanked yarn 220-240 M/kg.

The yarn should conform to the standards and specification as stipulated in the construction details of the Board. The Splicing should be 4" in length. In the case of Vycome Yarn, the number of splicing should not exceed more than 7 Nos in 100 Mtrs length and it should have a minimum breaking strength of 14 Kg. In the case of Anjengo yarn the number of splicing should be 5 Nos in 100 mtrs length. The inspection of all varieties of coir Yarn supplied by the perspective bidders will be conducted in the premises of Hindustan Coir at Kalavoor by the Officials authorized by the competent authority of the Board. The unacceptable lots will be rejected forthwith at the time of delivery at the factory premises.

The quotation should be accompanied by an amount of Rs.12,000/- (Rupees Twelve Thousand only) towards the Earnest Money Deposit (EMD) in the form of Demand Draft drawn in favour of Secretary, Coir Board drawn on any Nationalized Bank, in Alleppey. The Quotation without EMD will not be entertained. The suppliers whose EMD is already with Hindustan Coir, need not enclose the D.D for EMD, but it may mention in the technical bid. The quotationer has to furnish sample of coir yarn (not less than 1 kg) along with the quotation and the quotations without sample will be rejected.

The parties interested may respond in two separate sealed cover, i.e.


1. Cover I- Technical bid-containing the brief description of production capacity, production units, financial position, technical experience in the field of production and supply of coir yarn, labours strength, EMD etc. A list of suppliers may also be enclosed.
2. Cover II – Financial bid-Quotation for Coir yarn.

The two separate covers in a big cover super-scribing "Quotation for supply of coir yarn" should reach to the Weaving Master, Hindustan Coir, Kalavoor, Alleppey- 688522 **on or before 24.01.2017 at 3.00 P.M.** The quotations will be opened on the same day at 3.30 P.M in the presence of the quotationers, if any present. The committee will evaluate the technical bid and if required make an inspection to the concerned unit in order to check the accuracy of the technical bid and capacity of the supplier. The financial bid will be opened alongwith the technical bid. The quotations will be finalized only after conducting the inspection, if any, required.

The quotationer selected will have to execute an agreement on non-judicial stamp paper worth Rs.100/- with Hindustan Coir and also deposit an amount of Rs.10,000/- towards the Security Deposit and should make the supplies to Hindustan Coir as and when required without any interruption. The security deposits of suppliers which is already deposited with Hindustan Coir need not deposit again.

The validity period of the quotation will be of 6 months from the date of signing the agreement by the supplier. However Hindustan Coir will have the right to extend the validity period till new quotation is finalized. If the lowest quotationer to whom the supply order is placed fails to supply the yarn in the runnage as specified in the order within the stipulated time or default the conditions of supply in any other manner or refrains from undertaking the supply of yarn the supplier shall be liable to pay the difference in price of yarn procured from elsewhere and also pay compensation to the Board for the loss incurred thereby.

The Secretary, Coir Board, Ernakulam reserves the right to accept or reject any or all quotations or applications without assigning any reason what-so-ever.
