6. Income tax clearance certificate and audited financial statements for the last 3 years.

The financial bid in a separate sealed cover should contain the rate quoted per month per security guard adhering to the Minimum Wages act of Govt. of Kerala. Any other charges, taxes etc.. should be shown separately.

The successful bidder will be liable to remit an amount equal to the quoted amount for one month as security deposit and to execute a mutual agreement on a non judicial stamp paper worth Rs. 200/- at their own expenses.
