The terms and conditions for the disposal of the vehicles are as follows:

1. (a) The firm / tenderer interested to quote for the vehicle may submit their tender in the proforma given below along with earnest money of Rs.5000/- only in the form of DD drawn in favour of Secretary, Coir Board from Nationalized / Scheduled Bank, payable at Ernakulam, in a sealed cover superscribed with Tender for old and condemned staff car.

(b) The cost of tender form Rs.200/- may also be remitted as above.

2. The quotation may be addressed to Secretary, Coir Board, M.G.Road, Kochi - 682016 and sent so as to reach on or before 3 P.M. on 08.11.2017. The quotations will be opened on the same day i.e. 08.11.2017 at 3.30 P.M. in the presence of tenderers or their representatives who wish to be present at that time.

3. The vehicles will be disposed off on "as is where is basis" condition.

4. The successful tenderer will have to remove the vehicle at their own expenses immediately on confirmation after making the payment in the account of the Board. The details of which will be provided on confirmation.

5. The tenderers have to attach an attested copy of Ration Card / Voter I-Card / Aadhar Card / PAN Card and two recent passport size photographs duly attested.

6. The successful tenderer will be responsible for getting the registration certificate of the vehicle in his name expeditiously but in any case not later than one month, otherwise the EMD will not be returned. Coir Board will not be responsible for any lapse on the part of the successful tenderer in this regard.

7. The bidders will not be allowed to withdraw their bids in that event their earnest money will be forfeited.

8. Quotations received after due date/time and without earnest money will not be entertained.

9. The successful bidder who takes possession of the vehicle would be responsible for the bona fide use of the vehicles.

10. The Secretary, Coir Board reserves the right to accept or reject any / all the quotations without assigning any reason.
