The undersigned is directed to say that Ministry of Home Affairs had floated e-tender on 25-05-2017 for providing of commercial vehicle for shifting of its office located at NDCC-II Building, Jai Singh Road, New Delhi and Jaisalmer House, Man Singh Road, New Delhi to Major Dhyan Chand National Stadium, (MDCNS), India Gate, New Delhi. After examinations of quotations, a work order was issued to M/s Multicare Enterprises Pvt. Ltd., for taking up the said work. On receipt of work order, M/s Multicare Enterprises Pvt. Ltd., being Lowest-1, expressed their inability to take up the work.
