The Important Events/discussions/decisions pertaining to Coir Board for the month of March, 2016 are furnished below.

S&T ACTIVITIES

Hon'ble Chairman, Coir Board, was inaugurated the Pilot Scale Laboratory (PSL) set up for the production of PITHPLUS/ Testing at Regional Office of Coir Board at Pollachi on 8.3.2016. Shri. Manthrachalam, Hon'ble Member, Coir Board was also present at the occasion. The laboratory will cater to the requirement of testing of coir pith and coir fibre from coir entrepreneurs in that region. The technologies of Biochem treatment for quality improvement of coir fibre, Coir pith composting using Pithplus, Cocolawn etc were demonstrated and also the infrastructure facilities available in the PSL at RO, Pollachi for the production of Pithplus and Testing were explained to Chairman at the occasion. The technology of Biochem treatment at the occasion. The technology of Biochem treatment was also demonstrated to the participants in a Cluster meeting conducted at Thippampatti in connection with the stone laying ceremony of new Regional office complex at Pollachi on 3.3.2016.

All the technologies developed by the Board were disseminated before entrepreneurs who have attended the EDP training conducted under the Coir Udyami Yojana Programme held during the period from 14th to 18th March 2016. Demonstrations on the ecofriendly technologies of Biochem treatment for quality improvement of coir fibre, composting of coir pith using Pithplus and development of Cocolawn were also carried out before the entrepreneurs on that occasion.

The technologies developed were also disseminated to staff/ students from NCRMI(National Coir Research & Management Institute, Govt. of Kerala, Trivandrum & to the new batch of trainees at the NCT & DC on 16/03/2016.

The application of coir geotextiles for geotechnical applications were highlighted at the meeting on geosynthetics convened by the Bureau of Indian Standards at BTRA, Mumbai on 17th March 2017.

The new R& D Technologies developed were also disseminated to coir entrepreneurs in a 5 days Intensive **Training Programme** on coir pith and pith bio-products during the period from 14-18 th, March, 2016.

5days Intensive Coir Training was conducted on "Coir Polyester Moulding" to two lady trainees from 14.03.16 to 18.03.16. The training included theory and practical on coir fibre and pith preparation for moulding, polyester resin, cross linking chemicals, preparation of compound for the moulding, gel time and curing time of the composite, mould preparation, different types of moulds, preparation of moulds from plaster of paris and glass fibre, Negative mould preparation, moulding of different products from coir and polyester, finishing of the products, pigmenting etc.

The salient findings under collaborative project on "Material exploration and design development using coconut fibre for childrens' product and toys" with NID Ahmedabad was highlighted by presentation and display on 14.03.16. The Head ICNF, NID Prof.Pradyumansinh Jhala and the project coordinator Mr. Sajith Gopinath have represented NID.

COIR UDYAMI YOJANA

During March 2016 (upto 23.03.2016), Board has released an amount of Rs.2,19,75,367/- towards subsidy for setting up of 123 units under this scheme.

Coir Board Officials attended the meetings of the State Level Bankers' Committee, Kerala and RBI's Empowered Committee on MSME held at Thiruvananthapuram on 14th and 15th March 2015. The above committees reviewed the implementation of Coir Udyami Yojana in the State of Kerala and directed the Banks to consider the CUY applications pending with them.

COIR VIKAS YOJANA

A total no. of 1014 Nos. women workers were trained in spinning of coir yarn and manufacture of value added products. Besides 13 Nos.awareness programmes, 10 Nos EDP's, 3 Nos. Exposure tour,1 No. seminar, and 10 Nos. Workshops were organized in major coir producing centres during this month.

All line departments MSME (DG), KVIC, MSME Tool room, NSIC are attended the meeting along with Coir Board. Both Ministers are reviewed our Schemes and Programmes

The response of the exporters/entrepreneurs from Indian coir sector participated in the fair through Coir Board was very encouraging and the participants were generated a lot of trade enquiries for coir pith and garden articles.

II External Market Development Assistance

An amount of Rs. 6,96,802/- (Rupees Six Lakh Ninety Six Thousand Eight Hundred and Two Only) has been disbursed to Five Units as External Market Development Assistance for various export promotional activities abroad.

III Export Registration

Seven firms were newly registered as Coir Exporters and also issued Registration-Cum-Membership Certificate.

Export

The export of coir and coir products during the period from April 2015 to January 2016 is 537666 MT valued at Rs.138259.42 crores. This shows an increase of 12.2% in terms of quantity and 5.5% in terms of value, when compared to the corresponding period of the previous year.

ASPIRE

The Board has set up three Livelihood Business Incubation centres at Board's establishment namely Regional Office Rajahmundry, Bhubaneswar and Regional Extension Centre at Thanjavur. The startup training programme under ASPIRE scheme has been commenced successfully by first week of March 2016.
