Please refer to your RTI application dated 04.05.2018 addressed to the Ministry of Micro, Small and Medium Enterprises, Govt. of India on the subject cited. The information in respect of Coir Board is furnished below:

1. Coir Udyami Yojana (CUY)

Coir Board under the Ministry of MSME is implementing various Schemes of the Govt. of India for the development of Coir Industry in the country. Coir Udyami Yojana (CUY) was one among them. This was a credit linked subsidy scheme which provides 40% of the project cost as Govt. of India subsidy, 55% as Bank credit and 5% as beneficiary contribution. The Scheme would cover any coir project with project cost upto Rs.10 lakhs plus working capital, which shall not exceed 25% of the project cost. The loan under the Scheme is without collateral/third party guarantee as it is covered under the CGTMSE Scheme. The Scheme was opened to individuals, companies, Self Help Groups, Non Governmental Organizations, Institutions registered under Societies Registration Act 1860, Production Co-operative Societies, Joint Liability Groups and Charitable Trust. The Scheme has been implementing in major coconut growing States/UTs in the country. Every year separate target will be set out for these States/UTs so as to utilize the Govt. of India Grant allocated under the Scheme. This Scheme is now integrated with the Prime Minister's Employment Generation Programme (PMEGP). During the period from 2014-15 to till this date an amount of Rs.536.00 lakhs has been released to different Banks in the State of Andhra Pradesh towards pro-rata grant of the loans sanctioned under the Scheme for setting up of 191 coir units in the State. Year-wise breakup of the subsidy released to the Banks in Andhra Pradesh for assisting the coir projects under the Scheme is as follows:
