The tender form must accompany the earnest money of Rs.1,50,000.00(Rupees One Lakh Fifty Thousand Only) separately by demand draft in favour of The Joint Director(Tech), CICT, Coir Board payable at Bangalore. The tender form submitted without earnest money will not be considered. The earnest money of the unsuccessful bidder will be returned after finalization of the award to successful bidder.
7. In the event of acceptance of tender, the successful bidder be required to deposit full amount in shape of DD in favour of The Joint Director(Tech), CICT, Coir Board payable at Bangalore with in 7 days from the issue of order, failing which the sale order shall be cancelled and EMD will be forfeited accordingly.
