• ECOMARK Criteria for coir and coir products

The Ministry of Environment, Forest and Climate Change, Government of India has published the Gazette Notification on the ECOMARK Criteria for coir and coir products. The Board had been making constant efforts to get the approval of ECOMARK for coir products. Obtaining the ECOMARK is really an achievement to the Board and it will be encouraging all citizens to use and buy products which are environment-friendly, thereby improving the overall quality of the environment and promote sustainable management of resources in India.

• Visit of the Delegation headed by Shri. E. R. Srinivas, Minister of Small Scale Industries, Govt. of Karnataka

Shri. E. R. Srinivas, Minister of Small Scale Industries, Karnataka along with a team of 25 dignitaries visited Central Coir |Research Institute, Kalavoor on 4th, October 2018. The Director, RDTE has made a presentation on all the R&D technologies before the delegation. The delegation visited all the departments of CCRI and witnessed the operation of the MFEM, operation of spinning machine and weaving looms Anugraha, Anupam and Anugraha Tejas.

Technologies of injection moulding plastic with coir for production of chair and garden articles, development of flame retardant coir cushioning material, dyeing of coir using pantone shades and natural dyes were also displayed for the visitors. Demonstration for composting of coir pith, Krishimithra and quality improvement of coir fibre using Biochem formulation has been shown to the visitors. Spinning of coir/sisal fine yarn on the solar powered "Electronic Ratt" and production of diversified coir products have been exhibited to the visitors. Demonstration of making paper by using coir pulp and production of tufted coir mats in the Mini Tufting Plant at the Incubation centre was also done.

Exposure visit of International Delegates



• Coir Awareness program was organised on 18-10-2018 at Unemployed Welfare Society, Kavaratti, UT of Lakshadweep.





Facilitation of participation in Gardex, Chiba, Japan

Gardex is Asia's leading trade show for garden articles, outdoor living & building industry and attracts a vast number of buyers from all over Japan every year. The Board facilitated participation of Indian coir sector in the Gardex, 2018, Chiba, Japan held during 10-12 October, 2018, by setting up an 'Indian MSME Pavilion'. The response was very encouraging and the participants could generate a lot of trade enquiries and firm business orders for coir pith and garden articles.

Visit of Board members to the Ethamozhy Coir Cluster in Tamil Nadu

The products of the cluster are different varieties of Brushes and Brooms made of coir fibre. The Members of the Board were very much attracted by the products and appreciated the same and suggested that being eco-friendly Brushes and Brooms, these types of products shall be encouraged.

SFURTI II phase meeting

A meeting was conducted at the Project Office (Coir), Kayamkulam, Kerala on 08.10.2018 by Deputy Director (SFURTI) for ascertaining the progress of the implementation of Haripad Coir cluster. In the meeting it was noted that eventhough two Raw Material Banks were established at Haripad, they are not functional. Officers from the Coir Board also visited the CFCs of Haripad cluster to review its functioning.

Guptha, Additional Secretary, Govt. of Odisha & other senior officials and presented a road map for the development of Coir Industry in Odisha.
