Sealed competitive tenders are invited from reputed and popular artists who are experienced in doing art works using Coir, Coir products, Coconut products, Coconut tree materials, to do a relief mural art work using the above materials on two wooden panels inside a cabin in Udyog Bhavan, New Delhi.

Terms and Conditions and other Important aspects for submission of bids for Relief Mural Art Work on two wooden panels inside a cabin in Udyog Bhavan, New Delhi using Coir, Coir Products, Coconut Products, Coconut Tree Materials.

- 1. The quotations should be submitted in two bid system ie. Technical Bid and Financial Bid
- 2. The time for completion of the work is 15 days.
- 3. Payment shall be released on work done basis.
- 4. The bidders shall furnish an EMD of Rs.5000/- as DD in favour of Secretary, Coir Board.
- 5. Income tax and other taxes as per rules as applicable will be deducted by the Board at every stage of release of payment.
- 6. Any Tender received by Coir Board after the due date & time for submission of Tender prescribed by Coir Board will be summarily rejected.
- 7. Changes and alterations which materially alter the Tendered prices are not permitted after the opening of the Tender document.
- 8. Coir Board will open/ examine the financial bid of only those bidders whose Technical bid is found to be acceptable to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the Tenders are generally in order.
- 9. The Artist selected will have to execute an agreement with Coir Board in a stamp paper worth Rs.200/- and sign an integrity pact. Performance guarantee amount @ 5% of the work will have to be deposited by the successful bidder.
- 10. Conditional bidding of price and conditional offer of discounts will not be accepted and such offer can render the bids liable for rejection.
- 11. Incomplete bids, unauthenticated bids and bids received after the appointed time will be summarily rejected.
