Ministry of MSME, Government of India has formulated “Scheme of Fund for Regeneration of Traditional Industries (SFURTI), for the development of Village industries and Coir clusters in order to organize the traditional industries and artisans for their growth and long term sustainability. Coir Board is the Nodal Agency for the development of coir clusters under the scheme, undertakes the role of programme fund management, in addition to monitoring and evaluation of project implementation.

The scheme specifies the following institutional arrangement at the operational level:

- A Special Purpose Vehicle (SPV) be formed to develop and manage the cluster
- An Implementing Agency (IA) is appointed to undertake scheme implementation
- A Technical Agency (TA) is designated to assist and guide the scheme implementation

Rajkanika Coir Cluster is approved under the scheme. M/s.Rajkanika Coir SPV Trust, having administrative office at HIG 228 ,Kananbihar phase - 1, Post - Patia, Bhubaneswar , Dist - Khurdha, Odisha, PIN – 751031, is the Special Purpose Vehicle (SPV) of the Cluster. M/s. SNEHA is the Implementing agency of the cluster and M/s. APITCO Limited is the designated Technical agency for the cluster. The scheme envisages establishment of upgraded production infrastructure, as the Common Facility Center (CFC), for the manufacturing of coir products and stipulates the building construction and machinery procurement for the establishment of CFC should adhere the General Financial Rules (GFR) of Government of India. Accordingly, the EoI procedure is being undertaken for the procurement of machineries, equipments and its accessories. M/s. Rajkanika Coir SPV Trust, the Special Purpose Vehicle (SPV) of Rajkanika Coir Cluster, propose to establish a Common Facility Centre (CFC) in 5 locations with the financial assistance from Government of India under SFURTI.
