Swachhata Abhiyan of this Ministry including O/o DC(MSME), NSIC, KVIC, Coir Board, NI-MSME, EDI, and MGIRI, is being organized at their respective locations on 2nd October, 2020 from 10.00 A.M. to 1.00 PM to instill motivation for keeping the surroundings clean as part of wider "Shramdaan" activity while also maintaining COVID 19 guidelines.

The following steps to be carried out under "Shramdaan" activity:

- 1. COVID 19 guidelines may be followed while undertaking this drive.
- 2. Teams may be formed to undertake the cleanliness drive.
- 3. Individual Shramdaan will be the motive of this drive.
- 4. The corridors / staircase and rooms of the work place may be cleaned by way of brooming and dusting. For this purpose, GA Section may provide Masks, hand-wash. Temperature Measurement kit, gloves and sanitizers etc.
- 5. Individuals to put in all efforts to maintain cleanliness in their office rooms by way of cleaning ones own drawers, almirahs, computers, telephone, dustbin etc.
- 6. Remove unnecessary items and dispose them properly
- 7. Segregate unwanted material from the workplace

- 10. Out-sourced staff may be deployed only after cleanliness drive is over.
- 11. Officials will make their own arrangements for attending the office except entitled officers.
