Please refer to your RTI application dated 18/08/2021 on the subject cited. The information sought by you are furnished below.

**Reply to Question No.1:** Coir Board is not implementing the said scheme. So data is not available with Coir Board.

**Reply to Question No.2:** As per the revised operational guidelines of the Prime Minister's Employment Generation Programme (PMEGP) approved by the Ministry of MSME vide Office Memorandum No.PMEGP/Policy/5/2017 dated 27.03.2018, the Coir Board had been designated as an agency for implementing the Scheme in Coir Sector. Since 1st April, 2018 only, Coir Board has been implementing PMEGP in coir sector. Khadi and Village Industries Commission (KVIC) is the single nodal agency at the National level. The Margin Money (Subsidy) in respect of the coir units assisted under the Scheme is being released by the KVIC. So far the Ministry of MSME has not allocated any fund to Coir Board under PMEGP. Since 2018-19 as on date, Coir Board had assisted a total 341 nos. of coir units for which an amount of Rs.1380.33 lakhs has been released by the KVIC as Margin Money Subsidy under the scheme. For which a total number of 2387 employment opportunities have been created as a result of establishment of 341 nos. of coir units under the Scheme.

**Reply to Question No.3:** A total 1886 nos. of coir units have been established under Coir Udyami Yojana (CUY) during the period from 2015-16 to 2019-20 and during 2018-19 to 2021-22 as on date, 341 nos. of coir units have been established under PMEGP scheme.


