Please refer to your RTI application dated 30<sup>th</sup> July, 2021 on the subject cited. As far as Coir Board is concerned the information sought for by you is furnished below.

<u>Question no.1:</u> Government servant joint after 01.01.2004 is under New Pension Scheme or old pension scheme.

**Ans:** The Government Servant joined after 01.01.2004 is under New Pension Scheme (NPS)

Question no.2: If they come under NPS, how much contribution of NPS are being deducted from their salary towards NPS contribution on monthly basis. Please intimate percentage of employee share and government share/employer share.

**Ans**: The monthly contribution of the employees of the Board is 10% of the Basic Salary Plus Dearness Allowance (DA) and matched by the Board.

**Question no.3:** Under which rule NPS contribution are being deducted from their salary.

**Ans**: Please refer to the DO No. 5(68)2004-ECB & PR dated 16th August 2004, issued from the Ministry of Finance, Department of Economic Affairs, Government of India, New Delhi

<u>Question no.4:</u> If 10 percent Basic plus DA are being deducted towards NPS contribution (employer share Government share) then who is the approval authority to do so. If 14 percentage of Basic plus DA are being deducted towards NPS contribution(employer share/Government share) then what is the instruction, rule, guidelines for allowing paying 14% of NPS (employer share) to Government Servant.

**Ans**: Please refer to the DO No. 5(68)2004-ECB & PR dated 16th August 2004, issued from the Ministry of Finance, Department of Economic Affairs, Government of India, New Delhi. At present, Coir Board, functioning under the Ministry of MSME has been deducting 10% each as employee and employer contribution towards New Pension Scheme (NPS) until further orders from the concerned Ministry in this regard.
