#### **Terms and Conditions**

- 1. The intending bidders should be well experienced and reputed printing firms, who are based in Ernakulam District, Kerala having at least 3 years experience of executing similar work and having annual turnover of rupees One crore or more. The testimonials / records showing past experience, proof of turnover have to be furnished by the party. These documents shall essentially be included in the Technical bid.
- 2. The rate may be quoted after inspecting the specimen available at Coir Board Head Office (Administrative Department), Ernakulam during office hours (Monday to Friday between 9am -5.30pm).

- 3. The work should be completed and 300 copies of Annual Report 2021-22, have to be supplied to the Board within 7 days on final approval of the proof.
- 4. Before approval of the typed set material of Annual Report 2021-22, the complete proof of the Annual Report has to be vetted 3 times by the Board, for which direct interaction/discussion with the Board officers and representative of the printers would be necessary at Coir Board, Kochi and get the formal approval.
- 5. The Annual Report 2021-22 should be printed and supplied strictly as per the specification. Deviation from the approved specifications, terms and conditions, delivery schedule etc will not be allowed under any circumstances. No payment will be made in respect of supplies not conforming to the specifications, designs and conditions prescribed.
- 6. The rate should be inclusive of paper cost, layout, designing, printing and all taxes, charges, delivery charges and incidentals if any.
- 7. The State Emblem of India & Name of Ministry should be clearly printed on the cover page of Annual Report 2021-22.
- 8. The quotation along with documentary evidence to prove the credentials should be attached in the Technical Bid. Technical and Financial bids have to be submitted separately. (formats enclosed)
- 9. The technical bid should contain the following:
  - a. Name, address, telephone, email id, contact person of the firm
  - b. Constitution/Company profile (Detailed profile of the firm should be enclosed)
  - c. If the company is proprietary/ Partnership, give the name and address of proprietor/ Partners/ Directors
  - d. Registration certificate of the firm
  - e. GST Registration Certificate
  - f. PAN
  - g. Turn over for the last 3 years (2018-19, 2019-20, and 2020-21, audited statement should be attached)
  - h. Records showing past experience in printing of Annual Reports.
  - i. Declaration by bidder that they have not been blacklisted by Departments / Ministries of the Govt. of India or PSUs.

j. An amount of Rs. 10,000/- (Rupees ten thousand only) has to be remitted to the Board's Account bearing Account No.57009832813. IFSC Code SBIN0070261.

- 10. The price bid should be filled in the BOQ attached and should contain the following:
  - All inclusive, including printing and delivery charges at Coir Board Head Office, Ernakulam.
  - In the event of any excess pages are seen necessary beyond 300 estimated pages, the rates will be computed separately for which each bidder may quote the rates for per form of 4 pages (rates should be inclusive of paper cost, typesetting & printing)

11. The total number of Annual Report 2021-22, required by the Board is 300 Nos. In the event of additional copies, proportionate cost will be given.

12. The decision of the Board shall be final.

### General Terms.

- 1. The invitation for Bids is not an offer and is issued with no commitment. Coir Board reserves the right to withdraw the Invitation and change or vary any part thereof at any stage. Coir Board also reserves the right to disqualify any bidder, should it be so necessary at any stage.
- 2. Coir Board reserves the right to withdraw this invitation of Bids if it determines that such action is in the best interest of the Board.
- 3. Timing and sequence of events resulting from this invitation shall ultimately be determined by Coir Board.
- 4. The bidders shall have no claims whatsoever against Coir Board arising out of, or relating to this invitation of Bids or these procedures (other than those arising under a definitive service agreement with the bidder in accordance with the terms thereof).
- 5. Applicants who are found to canvass influence or attempt to influence in any manner the qualification or selection process shall be disqualified from the process at any stage.
- 6. By submitting a proposal, each bidder shall be deemed to acknowledge that he/she has carefully read all the conditions and limitations.
- 7. The bidders' proposals in the bid document will be evaluated as per the requirements specified in the invitation of Bids and adopting the qualification criteria spelt out in this invitation.
- 8. Coir Board reserves the right to short list the parties responding to this notice on the basis of the evaluation of the Technical Bids before opening of the financial bids. Submission of more than one bid by the same party will be a disqualification.
- 9. The rates quoted should be all inclusive and financial bids with condition discounts will not be entertained. The price quote should be expressed in words and figures. Correction / over writings etc. have to be avoided. Bids submitted through fax, e-mail etc. will not be accepted.
- 10. Deduction of taxes / levies as applicable from time to time will be made at source by the Board while releasing payment.
- 11. The selected agency will have to enter into an agreement in stamp paper worth Rs.200/- with Coir Board.
- 12. A pre-bid meeting will be held at Coir Board Head Quarters, Kochi at 2 pm on 06.10.2022 for providing clarifications/additional information to the intending bidders.
- 13. Bidder should not have been blacklisted by Departments / Ministries of the Govt. of India or PSUs for which Declaration has to be submitted.

- 14. A bid received without proof of EMD remitted shall be rejected as non-responsive at the bid opening stage.
- 15. Conditional tenders and tenders with conditional offers will summarily be rejected.
- 16. The terms and conditions in this bid document and the contract will be interpreted in Indian Laws and will be subject to Jurisdiction of Courts at Kochi, Kerala.
- 17. In the event of any occurrence of delay arises in time span for the printing and supply of Annual report, the bidder should be penalized, as decided by the competent authority.
- 18. "Force majeure" obligation of the supplier.

In the event of "Force majeure" as soon as responsibility practicable but not more than 48 hours following the occurrence of such an event, the printer and supplier shall notify the University of the Event of Force majeure stating inter alia the anticipated period of Force majeure during the required services are likely to remain affected and also the measures which the affected party has taken or proposes to take to alleviate/mitigate the impact of the Force majeure and to resume performance of such of its obligations affected.

Note: "Force majeure" means any event beyond the control of the printer and supplier, which is unavoidable notwithstanding the reasonable care of the party affected, and which could not have been prevented by exercise of reasonable skill and care and good industry practices and shall include, without limitation, any natural calamities, strike, unlawful lockout, riot, terrorist act etc.
