Sub: Implementation of the Modified Assured Career Progression Scheme (MACP) to the employees of Coir Board qualified up to 30.09.2023 - Reg.

In line with the approval of Ministry for extension of the MACP Scheme to the employees of the Coir Board w.e.f 01.09.2008 in lieu of the earlier ACP Scheme vide Ministry's letter No.2(18)/2019-Coir/801 dated 3rd November 2010, the duly constituted Screening Committees met on 29th March 2023 and recommended extension of the benefit of Financial Upgradation ie, one increment in the existing basic pay as on the eligibility date and immediate higher stage to the 14 employees (qualified up to 30.09.2023) as per the details given in the Annexure-1 attached.

The grant of financial upgradation under MACP Scheme will be governed by the Rules /Guidelines in the Annexure- I attached to the O.M. of the Ministry of Personnel, Public Grievances & Pension (Department of Personnel and Training) dated 19th May, 2009 and modified on dated 22nd October 2019.

On grant of Financial Upgradation the employees may exercise their option for fixation of pay either from the date of Financial Upgradation or on the date of accrual of Annual Increment. The option for pay, if any have to be received in Head Office within one month from the date of receipt of the this Order . If no option is received within the time stipulated, the pay will be fixed with effect from the date of financial upgradation.
