CIRCULAR

Subject: Compliance with Condemnation Procedure for Procurement of Machinery and IT Equipment

As per the orders of the Chairman, Coir Board, procurement of any machinery or IT-related equipment shall be undertaken only after the completion of the condemnation procedure.

In this regard, as per Rule 217 of the General Financial Rules (GFR), obsolete and unserviceable equipment must be reported in the prescribed format of GFR-10. All Office Incharges are, therefore, requested to furnish details of such equipment in the GFR-10 format at the earliest.

A Condemnation Committee at the Coir Board HO has been constituted to review the submissions and provide their recommendations before any proposal for new equipment is considered. The committee shall review and submit its recommendations before processing any proposal for new equipment procurement.

All concerned offices are requested to comply with the above instructions and ensure submission of the GFR-10 format prior to furnishing any new proposals for procurement of equipment.

GFR 10 format and direction of Chairman, Coir Board is also enclosed.
